DuPage County will follow up the debut of next year's spending plan with a series of public hearings designed to share information and gather community on the fiscal 2011 budget.

Scheduled for three separate locations, the forums will follow the Sept. 14 release of County Board Chairman Bob Schillerstrom's budget proposal for the upcoming year.

The hearings are slated for 7 to 9:30 p.m. Sept. 22 in the council chambers at Westmont Village Hall, 31 W. Quincy St.; 7 to 9:30 p.m. Sept. 23 in Room 2200 of Addison Village Hall, 1 Friendship Plaza; and 7 to 9:30 p.m. Sept. 28 in the council chambers at West Chicago Village Hall, 475 Main St.

Environment:

Electronic Recycling (including household batteries) will be Saturday, September 11, 2010 from 9 AM-Noon at the Public Works Facility at 821 W. Liberty, Wheaton.

The Wheaton Police Department still accepts expired and unused medications for safe disposal, so consider dropping pharmaceuticals off on the same trip. Police Dept. is on Liberty just west of the Public Works Facility.

If you're interested in conserving water and reducing your water and sewage bill, stop by City Hall to learn why a rain barrel might be right for you. As part of its [Water Conservation and Protection Program](#), the City's Water Division created a new display showing how a rain barrel works and explaining the benefits of using one. It is located just inside the rear (north) entrance to City Hall, 303 W. Wesley St.

Health:

The DuPage County Health Department reported mosquitoes in Wheaton tested positive for West Nile Virus. The hot weather following recent flooding is making the mosquito population even worse.

There are a number of things that you can do to protect yourself from West Nile Virus:

- During prime mosquito hours, wear light-colored, long-sleeved clothing, pants and socks, and apply mosquito repellent with Deet.

- Discard outdoor containers that can hold water. Empty water from wading pools or bird baths weekly.
- Keep grass cut short so mosquitoes will not hide there.
- To report standing water or excessive mosquito conditions, call the Wheaton Mosquito Abatement District answering service at 630-668-6844.

Housing Jan Kay

On August 18th the Wheaton League participated in the DuPage Housing Action Coalition meeting with community stakeholders regarding the intersection of affordable housing and transportation. This is an often overlooked correlation for those of us who live in the suburbs especially, even given the sparse supply of public transportation opportunities. While living close to the center of a town often offers an easy city/suburb commute, there is very little public convenience offered for other situations in our communities. This of course leads to the need to have an auto and the accompanying expenses. Lacking transportation is a large impediment in seeking job opportunities, thus limiting the ability to pay for one's housing costs.

The Center for Neighborhood Technology (CNT) presented an excellent research report showing the significant costs of transportation per family as well as the lack of understanding and knowledge regarding the impact of transportation deficits in the Chicagoland area.

I can't emphasize enough the importance of either attending in person or watching the cable 10 recordings of both the City Council sessions and the City Council Planning Sessions. Not only is it good to hear the many varied issue discussions among the Council, but it is also valuable to hear the concerns of the public through the venue of the Public Comment period prior to the stated agenda.

As one observes it is good to listen to the members of the Council as they bring out the various angles of the issue at hand, showing the differences in support or opposition for the agenda items. One can very much appreciate the importance of being able to freely express concerns and support which often helps the public understand the ideology of

the Council member. We can more fully perceive whether the particular member truly is representing our positions.

This year there have been important presentations given throughout the year.

One of these was the presentation and ensuing discussion of the consultant on the use of the former Hubble school property. One can find the report online to see the recommendations and reasoning of the consultant. The consultant has made two council appearances this year in the Planning Sessions, giving the members opportunity to ask questions and make comments among themselves. Of course public comment only takes place during the regular Council meetings.

The other very important presentation was made during the budget setting time for the Council. I have to admit that prior to this assignment for the League, I had never attended the City's budget presentation where one is able to hear and better understand the many aspects of the City's budget as presented by staff, and the reasons for the allocations in each department under the City budget. [One may also download all the information from the City's website.]

The League has many good positions which might well be impacted through any number of Council actions, so it is good for us to be present and make our presence known as well as be prepared to take action on our positions when we hear of the issues of the day in our Community.

We can be proud of the decorum and integrity of our City Council and staff.

Each of us is represented by one member from our quadrant as well as 2 members and the mayor elected by the whole. Be sure to get to know the person representing you as well as the at-large members. They would be glad to hear from you anytime, I'm sure.

Wheaton City Council Highlights

Meeting: Aug. 16, 2010

Sept. 15 is Wheaton Literacy Day

In honor of Literacy DuPage, a nonprofit organization that works to provide customized English language tutoring to help adults achieve independence, Mayor Gresk proclaimed Sept. 15, 2010, Wheaton Literacy Day. Mayor Gresk presented a proclamation to Tana Tatnall of Literacy DuPage. On Sept. 15, more than 30 Wheaton businesses will support Literacy DuPage through donations.

Council to Vote on Rezoning of Property for Medical Office Building

The City Council received a report from the Planning & Zoning Board recommending approval of an application to rezone property at 1621 and 1703 E. Roosevelt Road to allow for the construction of a 6,000-square-foot medical office building. The application also requested two landscaping setback variations. The Council directed the City Attorney to draft an ordinance for the Council's formal consideration, including an amendment that would require the applicant to pay money to the Sidewalk Fund instead of constructing a sidewalk. There currently is no sidewalk adjacent to the property under review.

Community Relations Commission Welcomes New Members

The Council approved the appointment of Tyler Birt and Ginny Christensen to the Community Relations Commission for terms expiring March 1, 2013, and July 2, 2012 respectively, to fill current vacancies on the commission.
